## A-3. Approval of Motions:

1. Approval of Jan Minutes
a. Mrs. Cherry moved, Kelly seconded, minutes approved.

A-4. Principal's Report (Ms. Trent)
a. Caleb will partner up with another school in order to get a teacher for arts (funded by state)
b. Caleb students are invited to sing at a River Cats Game in May
c. TK \& K enrollment is beginning. TK is indeed happening at Caleb, but they won't know until mid-April how many students they can accept.

## A-5. President's Report (Shana)

a. Discussion about if we are disseminating info adequately
b. Shana has contacted Merrill Domondon, he would like to discontinue being co-treasurer. Board voted unanimously to remove him from the role.
c. This year, auditor will check the work of treasurer. Next year, co-treasurers can possibly split the responsibility of the role.
d. Next year, Parliamentarian role will be open. If we know anyone who would like to be President eventually, Shana can start having them shadow her.
e. We are considering paying a stipend to library volunteer, Amy (she volunteers about 10-15 hours/week). No clear record of what we have paid in the past for similar service. Ms. Trent suggested around $\$ 21 /$ hour, which is what the district pays library tech's.
f. Shana suggested having Zen Martial Arts host a kids night the same night that we do a Parents Night Out fundraiser at a brewery, such as Lefty's. Enthusiasm for this idea.
